Official Information Act request

Thank you for your information request dated 9 August 2017 seeking information about median salary by occupation and gender.

Your request, initially made to the State Services Commission (SSC) was transferred to Te Puni Kōkiri to directly respond to on 23 August 2017 under section 14(b)(ii) of the Official Information Act 1982. A response was therefore due to you on or before 20 September 2017.

You have specifically asked for data covering the period 1 July 2015 to 30 June 2016:

- Median salary and salary spread by occupation and by gender (like the gender salary box plots in Figure 4.2 of the 2015 HRC report, https://www.ssc.govt.nz/sites/all/files/HRCReport-2015.pdf).
 - By department
- Female dominated occupations, at the ANZSCO occupation level 5 (or at level 4 if level 5 isn't possible). For this work, we define "female dominated" as at least 66% are female (the definition in the Employment (Pay Equity and Equal Pay) Bill).
 - o By department

Te Puni Kōkiri data is collected and reported to the State Services Commission, who collate it according to their own reporting requirements. Accordingly we endeavoured to provide the data you requested in the exact same format as that used by the SSC but were unable to because of the sample size. We have therefore opted to provide the data to you in a table format (refer below).
