## Official Information Act request

Thank you for your request dated 3 August 2020 for information related to nominations. Your request has been considered in accordance with the Official Information Act 1982 (the Act).

Your questions and my responses are set out below:

 May I ask how is your process of nominating people to the governance board and how many people registered within your registry.

Your request for the number of people registered is declined under section 18(e) of the Act, as the information does not exist. At the time of writing Te Puni Kōkiri does not maintain a centrally collated nominations registry of individuals. Rather, the nominations process is progressed by staff with the appropriate knowledge, depending on the nature of the position for which nominees are sought. Te Puni Kōkiri will shortly be moving to a centralised nominations process and this will likely enable us to answer questions such as this in future.

 How many people you have successfully nominated to a position from the past two years. May I have all the name of successful applicants and the position they have been successful on.

The relevant agency or Minister decides the successful nominees. Te Puni Kōkiri does not hold this information, rather our role is to put forward nominee names. This part of your request is therefore declined under section 18(g) of the Act as the information is not held, and there is no agency or Minister that holds the information.

 If possible, may I also get the list of positions that you have nominated people to from your registry in the past two year.

Requests from agencies or Ministers for nominee names, are manually logged in our official correspondence data base. I have attached a list of entries related to



"nominations" for the period 3 August 2018 – 3 August 2020. Please note, each entry may relate to more than one individual, i.e. a list of names may be put forward.

I trust my response satisfies your request.
