Summary of points from Workshop 1: Regions must benefit from Fund, not just main centres. Fair to say that ICT is just one aspect of regional development. Gathering knowledge in bigger centres and spreading it to wider communities is key. Connectivity is important for regions to have access to technology. Use ICT to promote Māori knowledge. Education, access and connectivity. Create ICT hubs. Enhance Māori digital economy. Cultural maintenance using virtual platform. Educate across generations, rangatahi engagement, capitalising kaumātua traditional knowledge. ICT is a broad concept, leave open to interpretation. Concentrate the Fund in Te Tairāwhiti first then roll out nation-wide. Collaboration and partnerships and how the Fund can enhance those.
