"I know you have a Nominations Service- board nomination database and frequently send board appointment positions within your database by way of email to encourage your database to apply.

May I kindly request the all emails you have send to your nomination service database from 1st Jan 2023 to 12 Jan 2024".

Your request has been considered in accordance with the Official Information Act 1982 (the Act).

We have interpreted your request to mean emails advising of board position vacancies and events that were of wide distribution to multiple members on our Nominations Service database, Te Pae Ārahi from 1 January 2023 to 12 January 2024.

Two documents have been identified as being in the scope of your request.

Some information has been withheld in accordance with the Act on the following grounds:

section 9(2)(a) - to protect the privacy of natural persons.

In making the decision to withhold information, I have considered the public interest considerations in section 9(1) of the Act.

## Purpose of this request

This e mail is a request for names for possible consideration for the board of a new entity, the Integrity Sports and Recreation Commission (the Commission). Manatū Taonga Ministry for Cul ure and Heritage (Manatū Taonga) is supporting the Minister for Sport and Recreation on appointments to this Commission.

# What is this new entity?

The Integrity Sport and Recreation Act 2023 (the Act) has just been enacted (one of the last pieces of legislation by the outgoing Parliament). It establishes the 7-9 person board of the Commission which will need to be in place prior to commencement of the Act which is due to be on 1 July 2024 or 'such earlier date to be appointed by the Governor-General by Order in Council. The Commission is an Independent Crown Entity under the Crown Entities Act 2004 (CE Act). Fees will be determined by the Remuneration Authority and have not yet been set.

The key functions of the Commission include:

- taking over the responsibilities of Drug Free Sport NZ which will be disestablished.
- to promote, advise and educat on integrity issues and threats to integrity within the sport and physical recreation sector and to develop and issue integrity codes; and
- to prescribe policies and procedures for complaints management and dispute resolution and investigate suspected breaches of integrity codes and threats to integrity.

### **Priority considerations**

Because the legislation has only just been enacted, we need to wait until after the General Election on 14 October 2023 and the formation of a government and the appointment of a Minister for Sport and Recreation before formal briefings can be considered by a Minister. The formal appointment process will then be in place. This will be an appointments priority for Manatū Taonga.

Consulting with Diversity/Population agencies is an integral part of our processes, hence this advice to you about this new and exciting entity and request for initial names by 17 October 2023. We do have a reasonable number of names on our database, but it is very important to ensure an appropriate matchup with the required skill sets and competencies required to be considered by the Minister in recommending appointments.

Although the new body may not formally commence until 1 July 2024, it is necessary to have appointments to the board of the Commission confirmed earlier to enable key decisions to be made.

### **Key Criteria for Appointments**

The new Act provides that when recommending appointments to the board of the Commission, the Minister must ensure that the board collectively has knowledge and experience in matters relevant to the functions of the Commission including in:

- law
- athlete and participant health and well-being
- sport and physical recreation sector participation and administration
- · human rights, in particular the rights of children and young people; and the rights of rainbow people
- te Tiriti o Waitangi

### Also:

at least two members having experience and expertise in te ao Māori and tikanga Māori.

The CE Act particularly section 29 provides for skill sets appropriate for the board of the Commission and diversity in Commission membership. This may include:

- diversity including gender, ethnicity and disabled persons
- · experience in governance particularly Crown governance
- expertise in financial governance
- · machinery of government experience
