## **Official Information Act request**

Thank you for your information request dated 21 March 2024. Your request has been considered in accordance with the Official Information Act 1982 (the Act). Your questions and our responses are as follows:

"Question (1): Did TPK publish a draft LTIB as part of the first round of public consultation, consulting on subject matter options?"

No. We chose an alternative process of public engagement and consultation which based on our knowledge and experience in working with iwi and Māori communities, we thought would work more effectively. This informed our draft Long Term Insights Briefings (LTIBs). This process included:

- Workshops, focus group workshops, one-to-one interviews, and an online survey.
- Testing our workshop approach with a group of rangatahi interns first to seek feedback from their perspective. We adapted the workshop slides and approach based on this feedback, which was that we needed to create a simpler version of the three scenarios for discussion, and to create simpler questions for participants to think about.
- Shifting our focus to the following questions:
  - What would thriving whānau look like to you in 2040? Or what is your vision of thriving whānau in 2040?
  - What, if anything, is currently preventing / would prevent your vision of thriving whānau in 2040 coming true?
  - What would need to change (at community level, system level or otherwise) to enable your vision of thriving whānau to come true?
  - o Why is it that these things need to change?
  - o If they changed, how would it help your vision of thriving whānau come true?
- Six focus group workshops being undertaken with community and rangatahi groups in the first half of 2022 (around 24 participants in total).

"Question (1A): If yes, are you able to provide a copy of, or link to, TPK's draft LTIB that was released as part of the first round of public consultation?"

Not applicable.

"Question (2): Did TPK publish a draft LTIB as part of the second round of public consultation, consulting on the draft content of the LTIB?"

No. We chose an alternative process of public engagement and consultation which informed our draft LTIB as detailed in response to Question 1.

"Question (2A): If yes, are you able to provide a copy of, or link to, TPK's draft LTIB that was released as part of the second round of public consultation?"
